## Wednesday, August 29, 2012

The Blue Hills Regional Vocational School Forty-Eighth District School Committee Special Summer-Session Meeting was called to order promptly at **7:30 p.m. on Wednesday, August 29, 2012** at the Blue Hills Regional Vocational Technical School, Room 402, 800 Randolph Street, Canton, Massachusetts. Chairman Joseph A. Pascarella, presided.

## 1. ROLL CALL and PLEDGE OF ALLEGIANCE \*

Chairman Joseph A. Pascarella announced that the District complies with the inception of the revised Open Meeting Law in effect, as of July 1, 2010. This meeting is being recorded in person by the recording secretary. All documents referred to within the meeting are in the Meeting-Record File. - 2. **Public Comment and Visitors with Business for the Committee** Selectman John Connolly was unable to attend the meeting, though invited.
- 3. **DSC Chair Report -** Chairman Joseph A. Pascarella stated that the primary reason for this special meeting was to receive recommendations from the Negotiations Team of the Personnel & Negotiations Subcommittee and requested a brief executive session to confer with the Personnel & Negotiation Subcommittee and Legal Counsel Matthew Tobin on the Blue Hills Educational Association (BHEA) Contract status.
  - Chairman Joseph A. Pascarella moved to approve by roll-call vote a call to move into executive session. Member Kevin
     L. Connolly made a motion to move into executive session. Motion was seconded by Member Fran Fistori. Motion was taken to a roll-call vote and it was UNANIMOUSLY

**VOTED**: to move into executive session to discuss collective bargaining, strategies and/or possible litigation under Open Meeting Law, Chapter 30A, Section 21 (a) (b), 2, 3 of the Commonwealth of Massachusetts General Laws. Open meeting discussion may have a detrimental effect on the bargaining or litigating position of the District School Committee, a public body. The Committee is currently in ongoing strategic contract negotiations.

Following executive session the Committee returned to open session and will proceed with an open-session vote.

## 4. DSC Subcommittee Reports -
