3. <u>PUBLIC HEARING – FY15 BUDGET</u> – Complete review of FY15 Proposed Budget, with questions and answers from all parties of interest.

Mr. Quaglia proceeded to present a powerful PowerPoint review of the FY15 Budget, thoroughly prepared and executed (Presentation on file.). This presentation reviewed all the aspects of the Tentative FY15 Budget. Following the presentation, comments, questions and answers were addressed. Mr. Joseph Greeley, a resident of the Town of Norwood and member of its Finance Commission, spoke in favor of the presentation of the budget stating, "The presentation was very easy to follow." There was discussion on the role of the Stabilization Funds. Mr. Greeley stated, "It is important for us to know why there is a 2.9% increase with the overall budget."
