#### 7. Administrative Reports:

7.1 Treasurer: Mr. Charles J. Gisondi was recognized by Chairman Flahive

7.1.1 **Warrant Approval:** Secretary Thomas Polito moved to approve **FY 17 Warrant** Number 8, dated December 6, 2016, in the amount of \$1,623,585.54. Motion to approve was seconded by Member Kevin Connolly. Motion taken to vote where it was PASSED **(5 Yes, -0 4 abstains) APPROVED.**

7.2 Assistant Superintendent/Personnel and Business: Mr. Steven Moore was recognized by Chairman Flahive. Mr. Moore stated that he had met with the Finance & Administration Subcommittee with a review of the FY18 Budget goals and objectives. He stated that the School to Career (STC) Program budget and personnel review is ongoing. A recommendation was made to move forward with continuous review of this program and updates. Chairman Flahive moved the question. Motion was made by Member Kevin L. Connolly, and seconded by Member Fistori and taken to a vote. Motion passed by MAJORITY

**Vote:** to accept the recommendations of Mr. Moore with reference to the STC Program PASSED.. (Chairman Flahive abstained from the vote.)

The MSBA has very significant criterions for moving forward with their funding and everything is being done to insure compliance with this project. (Part of the meeting record.)
